Regarding late fees, please note the following per our bylaws:

- Payment postmarked between 09/2 and 10/1 will assess a \$50.00 late fee
- Payment postmarked between 10/2 and 11/3 will assess a \$100.00 late fee
- Payment postmarked after 11/4 will assess a \$250.00 late fee*
- Any member that attends any Krewe event without paying the annual dues, shall be assessed a \$500.00 late fee

November 30 is the absolute final deadline to renew membership

Krewe members will vote on a proposed new budget and elect new officers at the General Membership meeting which will be held on Wednesday, November 4th at 6:00pm at Seville Quarter's Heritage Hall.
